## INTRODUCTION

To prepare for the launch of the eMPF Platform and the onboarding of the first batch of Mandatory Provident Fund ("MPF") trustees, the Secretary for Financial Services and the Treasury ("SFST") has made –

- (a) the Mandatory Provident Fund Schemes (Designation of Electronic MPF System) Notice ("System Designation Notice")
  (<u>Annex A</u>) under section 19I(1) of the Mandatory Provident Fund Schemes Ordinance (Cap. 485) ("MPFSO");
- (b) the Mandatory Provident Fund Schemes (Amendment) Ordinance 2021 (Commencement) Notice 2024 ("Commencement Notice") (<u>Annex B</u>) under section 1(3)(a) of the Mandatory Provident Fund Schemes (Amendment) Ordinance 2021 ("Amendment Ordinance 2021");

- (c) the Mandatory Provident Fund Schemes (Specification of Dates for Purposes of Section 19M(2)(a)) Notice ("Mandatory Use Notice") (<u>Annex C</u>) under section 19N of MPFSO; and
- (d) the Mandatory Provident Fund Schemes (Appointment of Dates for Purposes of Section 19U(4)) Notice, the Mandatory Provident Fund Schemes (Appointment of Dates for Purposes of Section 19Y(3)) Notice, and the Mandatory Provident Fund Schemes (Appointment of Dates for Purposes of Section 19Z(4)) Notice (collectively "Fee Control Notices") (<u>Annex D</u>) under section 19ZE of MPFSO.

## JUSTIFICATIONS

2. The Amendment Ordinance 2021 enacted by the Legislative Council ("LegCo") in October 2021 provides the necessary legal basis for the implementation of the eMPF Platform, and confers power on SFST to publish legal notices in the Gazette to put certain provisions of the Amendment Ordinance 2021 into operation when the eMPF Platform is ready for use. Such legal notices will be published in the Gazette by batches to dovetail with the phased onboarding of MPF trustees (in ascending order of their assets-under-management size).

3. In March 2024, the Mandatory Provident Fund Schemes Authority ("MPFA") confirmed to the Government that the eMPF Platform is ready for commencement of trustee onboarding, and that phased onboarding of trustees to the Platform that is well tested against the criteria of robustness, reliability, quality and user-friendliness could commence in June 2024, with full implementation expected to be achieved in 2025.

4. To effect the launch of the eMPF Platform on 26 June 2024 and the onboarding of the first batch of MPF trustees, namely, YF Life Trustees Limited ("YF Life") and China Life Trustees Limited ("China Life") on 26 June 2024 and 29 July 2024 respectively, we need to publish the first batch of legal notices in the Gazette.

## THE LEGAL NOTICES

5.	The purposes of the first batch of legal notices are summarised in

System Designation Notice	To designate the eMPF Platform as the electronic system under MPFSO to provide services and facilities to facilitate MPF trustees in performing their scheme administration functions and any other
	functions that may be specified in Schedule 12 to MPFSO <sup>1</sup> .
Commencement Notice	To appoint 26 June 2024 as the day on which the provisions covered in section $1(3)(a)^2$ of the Amendment Ordinance 2021 come into operation.
Mandatory Use Notice	To specify 26 June 2024 and 29 July 2024 as "material day" for the purposes of section 19M(2)(a) of MPFSO for the schemes of YF Life and China Life respectively, such that these two trustees are mandated to use the eMPF Platform (i.e. onboarding).
Fee Control Notices	To appoint 26 September 2024 and 29 October 2024 as "material day" for the purposes of sections 19U(4), 19Y(3) and 19Z(4) of MPFSO for the constituent funds of the schemes of YF Life and China Life respectively, such that these two trustees are mandated to make corresponding reduction in their fees charged on scheme members <sup>3</sup> .

<sup>&</sup>lt;sup>2</sup> These are technical amendments to reflect the streamlined workflow of MPF administration after the implementation of the eMPF Platform, covering different aspects such as registration and enrolment; contribution and default contribution recovery; transfer and withdrawal of accrued benefits of scheme members; giving notices and documents; supervision and investigation; maintenance of a register of members of registered schemes; matters related to register of members with unclaimed benefits; and other miscellaneous matters.

## PUBLIC CONSULTATION

8. We consulted the LegCo Panel on Financial Affairs on 18 March 2024 on the latest development of the eMPF Platform, including trustees' onboarding schedule and gazettal plan. Feedback from the Panel was generally positive, with some Members urging for early implementation of the eMPF Platform to bring material cost savings to scheme members and provide impetus for growth for the MPF industry.

## PUBLICITY

9. We will issue a press release upon gazettal of the legal notices. Separately, MPFA, eMPF Platform Company Limited, and the Project contractor will launch a series of marketing campaigns and publicity initiatives to promote the eMPF Platform, and will provide assistance / educational materials for scheme members and employers prior to the onboarding of their respective MPF schemes.

<sup>(</sup>a) the scheme administration fee to be charged by trustees must not exceed the eMPF Platform fee, such that there can be "straight pass-on" of cost savings (being the difference between the existing scheme administration fee charged by trustee on its scheme members and the future eMPF Platform fee payable by trustee) to scheme members; and

<sup>(</sup>b) the overall Fund Expense Ratio of MPF funds must fully reflect the cost savings to ensure that there is corresponding reduction in the overall fee level.


